Yacht Charter Bookings Terms and Conditions

If the ship-owner confirms at the terms and conditions than all valid travel insurance is obligatory for Yachtoo Ltd. bookings and it is a condition of accepting your booking that you agree you will have obtained adequate and valid travel insurance for your booking by the date of departure. Yachtoo Ltd. do not offer a comprehensive personal travel insurance policy. For more details please contact a member of yacht owner. Ship-owner full details like address phone and office address will be provided when the payment will be received on Yachtoo Ltd. bank account.

Unless otherwise stated in the charter conditions – in the description of yacht charter, down payment, deposit, full payment as defined under chosen yacht. The first payment must be received before the dead-lines indicated during the yacht charter on yachtoo.net payment section. Cancellation by the customer will not be refund and all the charges for the down-payment, deposit or full payment for any charter. Only when the customer send the complaint to the Yachtoo Ltd. via email address or contact via phone. In such a case the Yachtoo Ltd. will refer this complaint to charter company and reply to customer the results.

For all sailing holidays featured, you will be required to provide cover against any damage or loss to the vessel and either pay a deposit at the base to the ship-owner.

Once the booking is confirmed by Yachtoo Ltd. you will be provided with the option of either purchasing Yacht Damage Waiver or paying a Security Deposit. All the details will be preceded by ship-owner and end customer before the charter begins.

Cancellation by the charter company (ship-owner) or reduction of the price in the event of late delivery or damages of the vessel.

If the charter company (ship-owner) fails to provide the yacht, or at least an equivalent replacement yacht at the time agreed in the charter, the charterer (customer) may withdraw from this charter, but only when it is clearly stated between charterer (customer) and the ship-owner. Yachtoo Ltd do not take this responsibility. Only ship-owner can decide if the charterer will receive full reimbursement of all payments made under this charter. Yachtoo Ltd. is not a party for any disputes All other claims for compensation by the charterer are excluded, except in the case of intent and negligence by the charter company. If the charterer does not withdraw from the charter, he may claim for reimbursement of the charter price pro rata for the time for which the charter company failed to hand over the yacht. This action is taken without Yachtoo Ltd responsibility. Damage to the yacht and its equipment which does not prejudice its sea-worthiness and which allow the yacht to continue to be used in a reasonable manner shall not be grounds for withdrawal. A
